# SANTA MARGARITA FORD FIX-MY-RIDE CONTEST RULES

1. **Entry.** NO PURCHASE NECESSARY TO ENTER OR TO WIN. To enter: a) contestants will enter by submitting a word essay summarizing their current vehicle situation and explaining why their car needs to be repaired. What makes them or their family deserving? What makes their situation unique? Vehicle make, model and year needs to be included along with a photo of the vehicle. One entry per family. All entries must be legible. Illegible, incomplete, or mechanically reproduced entries will not be accepted. Sponsors not responsible for lost, late, delayed, mutilated, altered, illegible, postage due or misdirected entries. All ideas, concepts, photos, copyrighted material and trademarks contained in the written idea, and any and all rights to the idea's content, become the sole property of sponsor and may be used by sponsor without further compensation to entrant and will not be returned.

2. **Time.** Entries will be accepted between 6-23-08 and 7-20-08. All entries must be received by 11:59 pm on 7/20/08.

3. **Selection of Winner.** The Winner will be selected by a panel of Cox Media, Cox Charities and Santa Margarita Ford judges ("Judges") on or about 7-28-08 from the number of eligible entries received. The following criteria(s) and point system will be used to determine a winner. Four (4) criteria will be used consisting of 1) does car require renovation? 2) does engine require repair? 3) is person/family deserving? 4) is the entrant's situation unique?. Each criterion will be rated on the following point system, from 1 to 5, with 5 points being the highest. The winner will be chosen based upon the maximum number of total points. In the event of a tie, the family whose need is most compelling based on a point system of 1-5 will be the tie-breaking factor. The decision of the Judges are final.

4. **Prize. Grand Prize:** Car makeover and repair (the "Prize") with a total estimated retail value of up to \$15,000, TBD based on actual repairs needed by vehicle. No substitutions or cash equivalents allowed, except that all prizes are subject to availability and Cox Media or Santa Margarita Ford may substitute a prize or prize component of equal or greater value. Award of prize is subject to vehicle verification based upon description of repairs from essay submitted, Winner's proof of eligibility, including proof of residency and execution of an affidavit and release as described in section 8 below. and are the current registered owner of the entered vehicle at the time of entry.
